## Consultations

- Initial consultations must be in office and can last up to 1 hour.
- Follow up consultations can be 15 to 30 min and can be in office, on the phone or online.
- Naturopathic doctor consultations, lab tests and treatments are GST exempt.

## Lab tests

We provide a diverse variety of lab tests from standard tests to more in-depth functional testing. The following is a list of the most common testing options we provide, however this is not a complete list of all the lab tests we can do.

## Private Insurance Coverage

Many private insurance companies will cover consultations, lab tests, treatments or supplements provided by our doctors.

We are able to direct bill more than 80% of the insurance companies providing coverage. Please bring your insurance card to your appointment and we will determine whether we can bill your insurance provider directly.

Please note that each insurance company's policy is different and will have varying levels of coverage as well as method of payment. Some providers will pay us directly, others will reimburse the policy holder directly. Payment method is dictated by the insurance provider.
